We are glad to inform you that we have decided to organise the Twenty Second webinar on the topic "Awareness program on Extension / Upgradation of CBSE Affiliation". As you are aware, CBSE Provisional affiliation of your school expires on 31st March 2027. According to Appendix- VI clause (L) of Affiliation Bye-Laws 2018, online application for extension of affiliation has to be submitted, one year prior to the session in which affiliation expires. It is the responsibility of the school authority to apply for extension of affiliation with requisite fee as per the amended rules. You are requested to refer amendments in CBSE Affiliation Bye-Laws 2018.


CBSE SARAS Portal is designed in such a way that your school is able to get extension of Affiliation without Physical / Virtual inspection process, if your school fulfils the norms set by CBSE. This program may help you to secure grant of extension without inspection. This program will further give you an insight into the upgradation of affiliation and section increase through SARAS portal. This will update non-affiliated schools regarding processes involved in Fresh / Switch Over Affiliation categories. This webinar will help you to understand revised documentation, different amended norms to be taken care of and steps involved in the online application process through SARAS portal.

This program will be conducted online through "Google Meet" on Saturday, 31<sup>st</sup> January 2026. Timing will be 9.30 am – 4.30 pm with a break of 15 minutes at 11.30 am, 30 minutes at 1.00 pm and 15 minutes at 3.30 pm.
